## Order

1. The Defendant is to pay to the Defendant forthwith the amount of QAR 92,680.34, comprising:
  - i. QAR 60,720 in costs; and
  - ii. QAR 31,960.34 in outstanding interest.

## Judgment

1. On 5 August 2025, judgment was issued in this matter (*Spine LLC v Lamaison Hotel LLC* [2025] QIC (F) 36), under which the Claimant was awarded:
  - i. QAR 129,419 (Services Rendered);
  - ii. QAR 14,000 (Fees Incurred);
  - iii. QAR 88,500 (Notice Period);

**Total: QAR 231,919** (the 'Principal Sum').

- iv. interest on the amounts stated in paragraphs 1(i) and 1(ii) above, calculated at the rate of 5% per annum from 25 January 2023 to the date of actual payment; and
  - v. interest on the amount stated in paragraph 1(iii) above, calculated at the rate of 5% per annum from the date of this judgment to the date of actual payment.
2. Whereas the Principal Sum was paid on 26 October 2025, the interest on this amount remains outstanding as of the date of this judgment.

3. The purpose of this judgment is to clarify the precise amount that is owed in interest on the above-mentioned sums, in order that the Claimant may pursue enforcement proceedings in respect of the remaining judgment debt in this matter.
4. In calculating the amount of interest on the sums mentioned in paragraphs 1(i)-(iii) in accordance with paragraphs 1(iv) and 1(v), the combined total amount that is owed in interest as of the date on which the Principal Sum was paid is QAR 31,960.34.
5. Furthermore, on 8 April 2026, a costs judgment was issued ([2026] QIC (C) 4) in which the Registrar ordered the Defendant to pay the Claimant QAR 60,720 in costs. This amount also remains unpaid as of the date of this judgment.
